

# **Strikers Basketball Player and Parent/Guardian Agreement**

## **Players**

### **1. Attendance -**

We are aware that there may be circumstances that arise that cause you to miss a practice (e.g. vacation, illness, etc.) When this occurs, the player or parent/guardian is required to inform coaches with as much advance notice as possible.

**More than three (3) unexcused absences will result in the player losing play time and/or being dismissed from the team.**

### **2. Dress Code -**

Be properly dressed in proper athletic attire and proper shoes, **no jewelry is permitted to be worn during practices and games.**

### **3. Academics -**

Players are required to be in good academic standing during the duration of the player's time with the team.

### **4. RESPECT COACHES, TEAMMATES, OPPONENTS AND REFEREES. -**

Players are required to behave in a manner that displays good sportsmanship and positively reflects the team and its sponsors. Our goal is to build a team of players that consistently demand more of themselves, than is demanded by the coaches. Be coachable, hustle, display mental toughness, and be focused on the game.

## **Organization's Obligations:**

### **1. Coaching and Training -**

Coaches and representatives of the organization are required to provide coaching, training, and guidance to the Player.

### **2. Tournaments and Games -**

Coaches and representatives of the organization are required to arrange for the participation in tournaments, events, and games for the Player.

### **3. Safety -**

Coaches and representatives of the organization are responsible for the safety of the players during team activities to the best of their ability.

## **Termination:**

### **1. Notice -**

The Player or the Organization may terminate this agreement with 7 days written notice to the other party.

### **2. Immediate Termination-**

The Organization reserves the right to immediately terminate this agreement if the player fails to fulfill their obligations or behave in a manner that is detrimental to the Organization.

The Parent/Guardian is held financially liable for any damages caused by the Player or the Parent/Guardian and the Player may be barred from the team thereafter.
